1. Eligibility & Bonus Allocation

The Company offers a 30% deposit bonus on qualifying deposits, with a maximum bonus amount of \$500 per client. The bonus will be credited to the client's trading account upon receipt and confirmation of the qualifying deposit.

2. Non-Withdrawable Bonus

The bonus amount is non-withdrawable and cannot be transferred to another account. Only profits generated through trading activity may be withdrawn, subject to the conditions outlined herein.

3. Withdrawal Restriction – Bonus Forfeiture

Any withdrawal – whether full or partial – from the trading account prior to meeting the applicable trading volume requirement will result in the immediate and automatic removal of the entire bonus balance. No partial retention of the bonus will apply.

4. Eligible Instruments

7. Anti-Abuse & Fair Use Policy

The bonus is strictly monitored. The Company reserves the right to cancel the bonus – with immediate effect and without prior notification – if any of the following are detected:

- Hedging strategies between multiple accounts held by the same or related individuals
- Arbitrage or latency-based trading strategies intended to exploit the bonus
- Coordinated trading activity across multiple accounts
- Opening positions solely to accumulate volume without genuine market exposure (e.g., simultaneous opposing trades)
- Any other trading behavior deemed to be in abuse of this promotion

8. Disqualifying Events

The Company reserves the right to remove the bonus without notice in the event of:

- A chargeback or reversal of the qualifying deposit
- Breach of the Client Agreement or these Terms
- Account inactivity or dormancy during the promotion period
- Suspected fraud or money laundering activity
